# 1. TERMS AND CONDITIONS OF REQUEST FOR TENDER (RFP)

- 1. CIPC's standard conditions of purchase shall apply.
- 2. Late and incomplete submissions will not be accepted.
- 3. Any bidder who has reasons to believe that the RFP specification is based on a specific brand must inform CIPO before BID closing date.

Companies and Intellectual Property Commission

- 4. Bidders are required to submit an original Tax Clearance Certificate for all price quotations exceeding the value of R30 000 (VAT included). Failure to submit the original and valid Tax Clearance Certificate will result in the invalidation of this RFP. Certified copies of the Tax Clearance Certificate will not be acceptable.
- 5. No services must be rendered or goods delivered before an official CIPC Purchase Order form has been received.
- 6. This RFP will be evaluated in terms of the **80/20** system prescribed by the Preferential Procurement Regulations, 2001.
- 7. - 22. CIPC will enter into Service Level Agreement with the successful Service Provider.
- 23. CIPC reserves the right not to award this bid to any prospective bidder or to split the award.
- 24. Fraud and Corruption:

The Service Provider selected through this Terms of Reference must observe the highest standards of ethics during the performance and execution of such contract. In pursuance of this policy, CIPC Defines, that for such purposes, the terms set forth will be as follows:

- i. "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of CIPC or any personnel of Service Provider(s) in contract executions.
- ii. "Fraudulent practice" means a misrepresentation of facts, in order to influence a procurement process or the execution of a contract, to CIPC, and includes collusive practice among bidders (prior to or after Proposal submission) designed to establish Proposal prices at artificially high or non-competitive levels and to deprive CIPC of the benefits of free and open competition;

## 3. INTRODUCTION

CIPC's mandate is registration of companies, close corporations, cooperatives and intellectual property rights. Related services include the disclosure of information as well as dispute resolution arising out of infringements to these rights. Therefore, CIPC needs to ensure the integrity and efficiency of its processes in order to provide accurate information. To improve the competitiveness of the South African economy by enhancing the reputation of South African businesses and the business environment. The solution must include 200Mbps fibre connectivity and 200Mbps wiband wireless backup link auto fail over configured for head office, Hosted Firewall. The bandwidth for each branch must be 50Mbps fiber link and 50Mbps wireless backup link auto fail over configured. All branches breakout on the Head Office 200Mbps link to the internet. The solution must be robust, scalable and flexible to meet future growth and changes (e.g. a new building elsewhere) which will be billable once the services are implemented, commissioned and operational. # 5.2. Solution Scope

SUPPLY: MPLS connectivity for CIPC head office and its branches.

Bidders <u>MUST</u> provide a SDWAN Software Defined Wide Area Network (WAN), Multiprotocol Label Switching (MPLS) proposal must allow easy connectivity to current and future remote sites including partners and stockholders.


