CLASS 1	2-5,35,42-45	Chemicals used in industry, science and photography, as well as in agriculture, horticulture and forestry; unprocessed artificial resins, unprocessed plastics; manures; fire extinguishing compositions; tempering and soldering preparations; chemical substances for preserving foodstuffs; tanning substances; adhesives used in industry.
CLASS 2	3-5,16,17,19,35,42-45	Paints, varnishes, lacquers; preservatives against rust and against deterioration of wood; colorants; mordants; raw natural resins; metals in foil and powder form for painters, decorators, printers and artists.
CLASS 3	1,2,4,5,8,16,21,35,42-45	Bleaching preparations and other substances for laundry use; cleaning, polishing, scouring and abrasive preparations; soaps; perfumery, essential oils, cosmetics, hair lotions; dentifrices.
CLASS 4	1-3,5,7,12,35,42-45	Industrial oils and greases; lubricants; dust absorbing, wetting and binding compositions; fuels (including motor spirit) and illuminants; candles and wicks for lighting.
CLASS 5	1-4,10,29-32,34,35,42-45	Pharmaceutical and veterinary preparations; sanitary preparations for medical purposes; dietetic substances adapted for medical use, food for babies; plasters, materials for dressings; material for stopping teeth, dental wax; disinfectants; preparations for destroying vermin; fungicides, herbicides.
CLASS 6	7-21,25,26,35,42-45	Common metals and their alloys; metal building materials; transportable buildings of metal; materials of metal for railway tracks; non-electric cables and wires of common metal; ironmongery, small items of metal hardware; pipes and tubes of metal; safes; goods of common metal not included in other classes; ores.
CLASS 7	8,9,11,12,21,35,42-45	Machines and machine tools; motors and engines (except for land vehicles); machine coupling and transmission components (except for land vehicles); agricultural implements other than hand-operated; incubators for eggs.
CLASS 8	7,9,10,13,14,16,21,28,35,42-45	Hand tools and implements (hand-operated); cutlery; side arms; razors.
CLASS 9	10-12,16,25,35,42-45	Scientific, nautical, surveying, photographic, cinematographic, optical, weighing, measuring, signalling, checking (supervision), life-saving and teaching apparatus and instruments; apparatus and instruments for conducting, switching, transforming, accumulating, regulating or controlling electricity; apparatus for recording, transmission or reproduction of sound or images; magnetic data carriers, recording discs; automatic vending machines and mechanisms for coin-operated apparatus; cash registers, calculating machines, data processing equipment and computers; fire-extinguishing apparatus.
CLASS 10	5,9,35,42-45	Surgical, medical, dental and veterinary apparatus and instruments, artificial limbs, eyes and teeth; orthopedic articles; suture materials.
CLASS 11	4,6-11,17,20,21,35,42-45	Apparatus for lighting, heating, steam generating, cooking, refrigerating, drying, ventilating, water supply and sanitary purposes.
CLASS 12	7-9,11,28,35,42,44,45	Vehicles; apparatus for locomotion by land, air or water.
CLASS 13	28,34,35,42-45	Firearms; ammunition and projectiles; explosives; fireworks.
CLASS 14	6,7-13,25,35,42-45	Precious metals and their alloys and goods in precious metals or coated therewith, not included in other classes; jewellery, precious stones; horological and chronometric instruments.
CLASS 15	1,2,5,8,9,17,35,42-45	Musical instruments.
CLASS 16	1,2,5,8,9,17,35,42-45	Paper, cardboard and goods made from these materials, not included in other classes; printed matter; bookbinding material; photographs; stationery; adhesives for stationery or household purposes; artists' materials; paint brushes; typewriters and office requisites (except furniture); instructional and teaching material (except apparatus); plastic materials for packaging (not included in other classes); printers' type; printing blocks.
CLASS 17	1,2,6,16,19-21,35,42-45	Rubber, gutta-percha, gum, asbestos, mica and goods made from these materials and not included in other classes; plastics in extruded form for use in manufacture; packing, stopping and insulating materials; flexible pipes, not of metal.
CLASS 18	9,14,16,25,28,35,42-45	Leather and imitations of leather, and goods made of these materials and not included in other classes; animal skins, hides; trunks and travelling bags; umbrellas, parasols and walking sticks; whips, harness and saddlery.

CLASS 19	1,2,6,17,35,37,42-45	Building materials (non-metallic); non-metallic rigid pipes for building; asphalt, pitch and bitumen; non-metallic transportable buildings; monuments, not of metal.
CLASS 20	16,18,19,21,24-27,35,42-45	Furniture, mirrors, picture frames; goods (not included in other classes) of wood, cork, reed, cane, wicker, horn, bone, ivory, whalebone, shell, amber, mother-of-pearl, meerschaum and substitutes for all these materials, or of plastics.
CLASS 21	3,5-8,10,17,35,42-45	Household or kitchen utensils and containers; combs and sponges; brushes (except paint brushes); brush-making materials; articles for cleaning purposes; steelwool; unworked or semi-worked glass (except glass used in building); glassware, porcelain and earthenware not included in other classes.
CLASS 22	7,16,18,22-24,35,42-45	Ropes, string, nets, tents, awnings, tarpaulins, sails, sacks and bags (not included in other classes); padding and stuffing materials (except of rubber or plastics); raw fibrous textile materials.
CLASS 23	22-27,35,42-45	Yarns and threads, for textile use.
CLASS 24	9,10,20,22-27,35,42-45	Textiles and textile goods, not included in other classes; bed and table covers.
CLASS 25	9,10,14,24,28,35,42-45	Clothing, footwear, headgear.
CLASS 26	6,35,42-45	Lace and embroidery, ribbons and braid; buttons, hooks and eyes, pins and needles; artificial flowers.
CLASS 27	11,20,24,35,42-45	Carpets, rugs, mats and matting, linoleum and other materials for covering existing floors; wall hangings (non-textile).
CLASS 28	9,12-14,16,18,25,35,42-45	Games and playthings; gymnastic and sporting articles not included in other classes; decorations for Christmas trees.
CLASS 29	5,30-33,35,42-45	Meat, fish, poultry and game; meat extracts; preserved, frozen, dried and cooked fruits and vegetables; jellies, jams, compotes; eggs, milk and milk products; edible oils and fats.
CLASS 30	5,29,31-33,35,42-45	Coffee, tea, cocoa, sugar, rice, tapioca, sago, artificial coffee; flour and preparations made from cereals, bread, pastry and confectionery, ices; honey, treacle; yeast, baking-powder; salt, mustard; vinegar, sauces (condiments); spices; ice.
CLASS 31	5,29,30,32,33,35,42-45	Agricultural, horticultural and forestry products and grains not included in other classes; live animals; fresh fruits and vegetables; seeds, natural plants and flowers; foodstuffs for animals, malt.
CLASS 32	5,29-31,33,35,42-45	Beers; mineral and aerated waters and other non-alcoholic drinks; fruit drinks and fruit juices; syrups and other preparations for making beverages.
CLASS 33	5,29-32,35,42-45	Alcoholic beverages (except beers).
CLASS 34	5,35,42-45	Tobacco; smokers' articles; matches.

CLASS 35	ALL CLASSES	Advertising; business management; business administration; office functions; retail & wholesale services
CLASS 36	9,16,19,35,42-45	Insurance; financial affairs; monetary affairs; real estate affairs.
CLASS 37	11,12,16,18-20,27,35,36,42-45	Building construction; repair; installation services.
CLASS 38	9,16,35,42-45	Telecommunications.
CLASS 39	9,12,35,42,44,45	Transport; packaging and storage of goods; travel arrangement.
CLASS 40	1,35,42-45	Treatment of materials.
CLASS 41	9,16,28,35,42-45	Education; providing of training; entertainment; sporting and cultural activities.
CLASS 42	ALL CLASSES	Scientific and technological services and research and design relating thereto; industrial analysis and research services; design and development of computer hardware and software.
CLASS 43	ALL EXCEPT 12 & 39	Services for providing food and drink; temporary accommodation.
CLASS 44	ALL CLASSES	Medical services; veterinary services; hygienic and beauty care for human beings or animals; agriculture, horticulture and forestry services.
CLASS 45	ALL CLASSES	Legal services; security services for the protection of property and individuals; personal and social services rendered by others to meet the needs of individuals.
