The CIPC Commissioner, Advocate Rory Voller and CIPC invites you to join a CIPC XBRL Taxonomy Webinar workshop to participate in the taxonomy development process to create a GRAP taxonomy.

The XBRL taxonomy needs to incorporate the Generally Recognized Accounting Principles (GRAP) so that State Owned Companies can also submit annual financial statements to CIPC in the XBRL format. The GRAP standards have been assessed for incorporation into the CIPC taxonomy and the CIPC has embarked on an initiative to update the CIPCs taxonomy accordingly. The CIPC taxonomy development service provider (BR-AG) have performed an analysis of the GRAP standards that will be incorporated. During the workshop, the results of the gap analysis will be presented.

Please also note that the attached Gap Analysis Report and Presentation includes both GRAP and IFRS elements. For the purposes of the workshop please only review the GRAP related components a few days prior to the meeting.

The workshop is scheduled for the 4th of June 2020 between 10H00 and 11H30 via a Microsoft Teams Webinar (see link above). Please join the webinar at least 30 minutes before it is scheduled to commence and familiarize yourselves with the platform and its controls which will allow you to do the following:
