

PRACTICE NOTICE NO.05: PATENTS STAKEHOLDERS

PRACTICE NOTE: ISSUANCE OF NOTICES OF ACCEPTANCE & OFFICIAL ACTIONS IN RESPECT OF PATENT APPLICATIONS; AND e-FILING OF OUTSTANDING DOCUMENTS ACCOMPANYING PATENT <u>APPLICATIONS</u>

- 1. This Practice Notice is applicable to issuance of Notices of Acceptance & Official Actions in respect of patent applications; and e-filing of outstanding documents accompanying patent applications (i.e. late lodgement on form P5).
- 2. Regulation 38 of the Patents Act 57 of 1978 prescribes for the lodgement on form P5 of a document which did not accompany an application in terms of regulation 22(1). The Patents Division of the CIPC ("the Patent Office") will introduce new e-filing functionality on IPonline, to enable applicants to electronically submit outstanding documents accompanying patent applications with effect from 12 December 2022. The new functionality will allow patent applicants to lodge documents listed in **Annexure A** of this Notice. The new e-filing functionality can be accessed at http://iponline.cipc.co.za/.
- 3. The Patent Office will, from 12 December 2022, issue Notices of Acceptance and Official Actions in respect of patent applications via the email address functionality. Patent applicants will be able to use the e-mailed link to download Notices of Acceptance and Official Actions.
- 4. The operational requirements in respect of e-filing of outstanding documents are detailed at:

- 6. A transition period is provided until end of January 2023 in respect of this e-filling and e-mail address functionality. From 01 February 2023, the Patent Office will no longer accept nor process late lodgements (P5 forms) which are not submitted via the new e-filing functionality.
- 7. Furthermore, from **01 February 2023**, the Patent Office will no longer issue hardcopies of Notices of Acceptance or Official Actions in respect of patent applications.
