



Overview

What does the Learn-i-Biz Course entail?

The Learn-i-Biz Course is an educational initiative designed to equip SMME directors and entrepreneurs with fundamental knowledge of their duties and responsibilities, fostering better compliance with the Companies Act, 2008.

Target Audience

Who is the ideal candidate for this program?

Though the online course is designed for prospective, new, and existing directors of SMMEs, any person that is interested are welcome to do the course as well.

Enrolment Cost

Is there a tuition fee or any associated costs?

The programme is free of charge.

Duration

What is the expected timeline for completion?

The course can be completed in approximately two hours. But you can progress at your own pace. The system saves your progress, so you don't need to finish in one sitting. You can return at any time.

Certificate

Do I get proof that I completed the course?

Yes, you can get a certificate of completion after completing the course successfully. It should be noted though that this is not an accredited course.

Once a student has answered all the questions at the end of each of the 7 modules and scored 80% or higher for each module, the certificate of completion can be downloaded and/or printed.
