1. Terms and conditions of request for proposal (RFP)

1. CIPC's standard conditions of purchase shall apply.
2. Late and incomplete submissions will not be accepted.
3. Any bidder who has reasons to believe that the RFP specification is based on a specific brand must inform CIPC before BID closing date.
4. Bidders are required to submit an original Tax Clearance Certificate for all price quotations exceeding the value of R30 000 (VAT included). Failure to submit the original and valid Tax Clearance Certificate will result in the invalidation of this RFP. Certified copies of the Tax Clearance Certificate will not be acceptable.
5. No services must be rendered or goods delivered before an official CIPC Purchase Order form has been received.
6. The successful bidder, which includes active company directors, contracted and subcontracted service providers and resources assigned to the project, will undergo a security screening process conducted by State Security Agency (SSA). The appointment is contingent upon the positive results of this security screening process. If any serious negative information arises during this process, the CIPC reserves the right to request the bidder to remedy the situation within a specified period, and if not possible, the CIPC reserves the right to withdraw the award.
7. This RFP will be evaluated in terms of the **80/20** system prescribed by the Preferential Procurement Regulations, 2001.
8. The bidder must provide assurance/guarantee to the integrity and safe keeping of the information (that it will not be amended/corrupted/distributed/permanently stored/copied by the service provider) for the duration of the contract and thereafter. Failure to submit will invalidate the bid proposal.
9. CIPC reserves the right to negotiate with the successful bidder on price.
10. The service provider must ensure that their work is confined to the scope as defined.
11. Travel between the consultant's home, place of work to the DTIC (CIPC) vice versa will not be for the account of this organization, including any other disbursements.
12. The Government Procurement General Conditions of contractors (GCC) will apply in all instances.
13. As the commencement of this project is of critical importance, it is imperative that the services provided by the Service Provider are available immediately. Failing to commence with this project immediately from date of notification by CIPC would invalidate the prospective Service Provider's proposal.
14. No advance payment(s) will be made. CIPC will pay within the prescribed period as per the PFMA.
- 15. All prices quoted must be inclusive of Value Added Tax (VAT)**
- 16. All prices must be quoted in South African Rand**
- 17. All prices must be valid for 120 days**
18. The successful Service Provider must at all times comply with CIPC's policies and procedures as well as maintain a high level of confidentiality of information.
19. All information, documents, programmes and reports must be regarded as confidential and may not be made available to any unauthorized person or institution without the written consent of the Commissioner or his/her delegate.

20. The successful bidder must ensure that the information provided by CIPC during the contract period is not transferred/copied/corrupted/amended in whole or in part by or on behalf of another party.
21. Further, the successful bidder may not keep the provided information by way of storing/copy/transferring of such information internally or to another party in whole or part relating to companies and/or close corporation. As such all information, documents, programs and reports must be regarded as confidential and may not be made available to any unauthorized person or institution without the written consent of the Commissioner or his delegate.
22. The service provider will therefore be required to sign a declaration of secrecy with CIPC. At the end of the contract period or termination of the contract, all information provided by CIPC will become the property of CIPC and the service provider may not keep any copy /store/reproduce/sell/distribute the whole or any part of the information provided by CIPC unless authorized in terms of the declaration of secrecy.
23. The Service Provider is restricted to the time frames as agreed with CIPC for the various phases that will be agreed to on signing of the Service Level Agreement.
24. CIPC will enter into Service Level Agreement with the successful Service Provider.
- 25. CIPC reserves the right not to award this bid to any prospective bidder or to split the award.**
- 26. Fraud and Corruption:**

The Service Provider selected through these Terms of Reference must observe the highest standards of ethics during the performance and execution of such contract. In pursuance of this policy, CIPC Defines, that for such purposes, the terms set forth will be as follows:

- i. "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of CIPC or any personnel of Service Provider(s) in contract executions.
- ii. "Fraudulent practice" means a misrepresentation of facts, in order to influence a procurement process or the execution of a contract, to CIPC, and includes collusive practice among bidders (prior to or after Proposal submission) designed to establish Proposal prices at artificially high or non-competitive levels and to deprive CIPC of the benefits of free and open competition;
- iii. "Unfair trade practices" means supply of services different from what is ordered on, or change in the scope of work;
- iv. "Coercive practices" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the execution of contract;
- v. CIPC shall reject a proposal for award, if it determines that the bidder recommended for award, has been engaged in corrupt, fraudulent or unfair trade practices;
- vi. CIPC also reserves the right to terminate this Agreement by giving 10 (ten) business days written notice to the service provider due to any perceived (by CIPC) undue reputational risk to CIPC which CIPC can be exposed to resulting from the service provider or its management/directors being found to be involved in unethical behavior, whether in its dealings with CIPC or any other business dealings. Note: "Unethical behavior" includes but not limited to an action that falls outside of what is considered morally right or proper for a person, a profession or an industry**

- vii. CIPC shall declare a Service Provider ineligible, either indefinitely or for a stated period of time, for awarding the contract, if at any time it determines that the Service Provider has been engaged in corrupt, fraudulent and unfair trade practice including but not limited to the above in competing for, or in executing, the contract.
 - viii. The service provider will sign a confidentiality agreement regarding the protection of CIPC information that is not in the public domain.
27. The successful bidder, which includes active company directors and resources assigned/deployed to the project, will undergo a security screening process. The appointment is contingent upon the positive results of this security screening. **If any serious negative information arises during this process, the CIPC reserves the right to request the bidder to remedy the situation within a specified period, and/or if not possible, the CIPC may withdraw the award.**
28. Occupational Health and Safety Obligations
- i. CIPC is committed to ensure a safe work environment, imposing protection towards the health and safety of all personnel and preventing workplace injuries or losses. Mandataries/ service providers are employers, with duties prescribed in the Occupational Health and Safety Act No. 85 of 1993 as amended and other legislative obligations. Mandataries/ service providers shall strictly adhere to and ensure that their personnel adhere to the provisions of the OHS Act 85 of 1993 inclusive of required OHS obligations (CIPC OHS requirements and all other applicable legislation). The awarded service provider is required to provide assurance by submitting the necessary and/or obligated Occupational Health and Safety requirements to CIPC.
 - ii. The necessary and/or obligated Occupational Health and Safety requirements include:
 - Bidding Companies valid COIDA Letter of Good Standing, or a licensed compensation insurer.
 - Bidding Companies signed Health; Safety & Environmental Policy Signed by Bidder's CEO OHS Act Section 16(1).
 - The Acceptance of Occupational Health and Safety Legislative Obligations and Other Requirements. Upon Award, the following OHS Obligations shall be applicable but are not limited to:
 - The Occupational Health and Safety Act 85 of 1993 Section 37(2) Agreement
 - Other Occupational Health & Safety requirements (OHS file) compliance specific to the scope.

- b) The bid document must be marked with the bidder's name
- c) The bid documents **must be signed** by an authorized employee, agent or representative of the bidder and each and every page of the proposal shall contain the initials of same signatories
- d) All pages of the submitted proposal must be numbered.

SUBMISSION OF USB

a) NO DISC WILL BE ALLOWED

- b) **ONE (1) USB must be submitted, including technical proposal as well as price proposal saved in separate folders;**
- c) The USB must be marked with the bidder's name.
- d) **The USB must have an index page/ table of contents listed all documents included in the proposal for easy referencing during evaluation (group information in separate folders)**
- e) **Open each folder prior submission to ensure that documents are saved and are properly opening and working**
- f) **BIDDERS TO VERIFY IF DOCUMENTS ARE SUCCESSFULLY LOADED IN THEIR USB'S**
- g) **USB'S WITH NO DOCUMENTS INCLUDED WILL BE DISQUALIFIED AS ONLY USB'S ARE USED FOR EVALUATION PURPOSES**

- b) The price envelope must be marked with the bidder's name
- c) Bidders to complete pricing schedule SBD 3.3 (Annexure "C")- **REFER TO ATTACHED SBD FORMS**
- d) **The total price (ceiling price) must be carried over to BOTH SBD 3.3 (Pricing Schedule) and SBD FORM 1: (Invitation for Bids). AND COMPLIANCE TO ANNEXURE A PAGE 23&24**
- e) The total bid Amount will be used for the evaluation of bids therefore it must be inclusive of all costs for the duration of the contract.

2. Purpose

This ToR sets out the end-to-end requirements for a single, experienced Events Management Company (EMC) to plan, manage, and deliver a world-class CRF international conference as a turnkey solution. It aligns with the approved Business Case and anticipates that CRF and CIPC may request changes, adjustments, and approvals during planning and delivery.

3. Background

CIPC came into existence in May 2011 after being established by the Companies Act, 2008 (Act 71 of 2008), herein after referred to as the Companies Act, as a juristic person to function as an organ of state within the public administration, but as an institution outside the public service.

In compliance with the Companies Act 2008, CIPC must provide the following services:

- Registration of corporate entities and intellectual property rights;
- Maintenance of accurate, up-to-date and relevant information concerning companies, corporate entities and intellectual property rights, and the provision of that information to the public and to other organs of state;
- The promotion of education and awareness of company and intellectual property laws, and related matters;
- The promotion of compliance with the Companies Act, and any other applicable legislation;
- Widest possible enforcement of the Companies Act;
- Promotion of the reliability of financial statements by monitoring compliance;
- Promoting voluntary resolution of disputes arising in terms of the Companies Act; and
- Research and reporting on matters of national policy and intellectual property law.

The CRF (Corporate Registrar's Forum) Executive Committee invited CIPC to bid to host the annual CRF conference in South Africa during 2027. Hosting the conference advances national priorities (tourism, SMME support), strengthens regional collaboration, and showcases corporate registry innovation. CIPC intends to appoint a single EMC to deliver the full solution under the oversight of CIPC / CRF Steering Committee.

4. **High Level Objectives**

1. **Deliver a world-class, professional international conference** reflecting CIPC's capabilities and CRF's standards. CRF conferences attract delegates and speakers from **70+ jurisdictions**, including senior registry officials, experts, and industry partners.
2. **Provide a turnkey solution** spanning planning, procurement, logistics, program, technical production, marketing, finance administration, stakeholder management, and post-event legacy deliverables.
3. **Special focus to enable regional participation and knowledge exchange.**
4. Preference to be provided to suppliers that promotes and support SMMEs and eco-friendly / green principles.
5. **Hybrid Delivery & Digital Engagement.** Streaming, recording, interactive digital content, and hybrid participation (virtual attendees, Q&A, polling) are core components to ensure an immersive and integrated service.
6. **Structured Networking & Cultural Events.** Provide for networking and cultural exchange through formal and informal networking opportunities.

PLEASE NOTE: CIPC reserves the right to procure only selected services based on the solution proposed, e.g. CIPC may elect to acquire the installation and implementation from one supplier, and the ongoing support from another.

5. **Scope of Work**

The EMC shall be responsible for the following workstreams and tasks (including supply, coordination, staffing, contracting, event compliance obligation and quality control) under guidance and final decision of CIPC:

5.1 Conference Design & Program Management

- Co-create conference concept/theme, program tracks, and agenda with CRF/CIPC.
- Speaker management: Save the dates, invitations, contracts, travel/accommodation, briefing, on-site hosting.
- Panel facilitation, protocol, and VIP handling (holding room) (Commissioner, international registry leaders).
- Provision for **simultaneous interpretation** to French and Arabic, translation of materials, and interpreter booths.

5.2 Venue Sourcing & Event Operations

- Source a minimum of 3 suitable venues 4–5-star venues in Cape Town capable of **200–300 delegates**, with back utilities (electricity & water) for the duration of the event, universal access, plenary and breakaway rooms, exhibition space, speaker prep areas, and on-site banqueting. Options previously reviewed include premium hotels near the CTICC and Bantry Bay; final selection to be proposed by EMC. The venues must be certified in terms the National Building Regulations and Building Standards Act no. 103 of 1977 as amended. Furthermore, venues shall have in place valid required compliance certification and documentation.
- Venue inclusions:
 - Event area set-up (2-3 days) and event breakup (1 day);
 - Event room rental (3 full days + 2 half days),
 - Furniture (round tables and chairs for delegates),
 - Technical equipment,
 - Access control and admission (passes)
 - Stage set up which includes panel seating,
 - Internet,
 - Water and mints on the table (preferable that each delegate received own water (not shared) and is replenished 3 times days during the day during breaks,
 - Table décor;
 - Lunch for 5 days that provides for different special dietary requirements, with one day celebrating a South African food tradition e.g. Braai.
 - Two breaks on full days, and one break on half days which includes coffee/tea, refreshments, and juice.
- Room layouts (plenary, round tables), signage, wayfinding, registration desks, and concierge.
- Daily catering plans aligned to program (tea/coffee breaks, lunches, special lunch, social events).
- Create and manage electronic platform to accept proposed presentations, AND logistical and event information to delegates.
- Design, create, and host an electronic, interactive guide for delegates that provides detail surrounding all the events, times, weather, proposed dress code.
- Creation and administration of WhatsApp site for real-time updates and information to delegates before arrival, during and after.
- All catering services and venues shall be in accordance with the regulations governing general hygiene requirements for food premises, the transport of food and related matters.

5.3 Social Functions & Experiences

- Cocktail/Sundowner event (venue, food & drinks, entertainment, transport).
- Gala dinner (venue, catering, décor/table settings, live music/entertainment, transport).

- Dinners on other conference evenings (venue, catering, entertainment, transport).
- Excursions (e.g., Table Mountain guided hike, wine routes, Robben Island, game drives) including guided services at the excursion and transport towards the excursion, tickets, food & drinks, transport, and risk/safety plans.
- Social functions and experiences must be design to show case Cape Town and its rich heritage aligned to the general theme.

All catering services and venues shall be in accordance with the regulations governing general hygiene requirements for food premises, the transport of food and related matters.

5.4 Technology & Hybrid/Virtual Access

- End-to-end **live streaming**, recording, editing, and postproduction of sessions.
- Conference app/website integration (program, maps, alerts, Q&A, polling), technical support team, and Wi-Fi coordination.
- Temporary storage of electronic material and providing such on format agreed to post conference.

5.5 Marketing, Branding & Communications

- Develop:
 - **conference website that includes pre-conference information, facilitates registration (integrated with payment system)**, booking options for social events, accommodation options, other tourist attractions for delegates arriving early or staying later.
 - digital marketing plan,
 - content calendar,
 - social/PR,
 - WhatsApp group for real-time updates and information to delegates before arrival, during and after, and
 - media kits based on CRF and CIPC CI manuals.
 - Invitations and support for sponsors, speakers and panelists, and media.
- Design and production of **printed materials** (badges, agendas, banners, menus etc).
- Design and production or procurement of delegation packs, speaker gifts and awards.
- Design and production of handover symbol (usually a trophy or statue) to the next years hosts.
- Real-time content release of the conference content on social media platforms.
- Group photo of delegates to be printed in A4 and presented in branded folder and attendance certificate with each delegates name and issued on the last day of the conference.
- Sponsor prospectus, branding rights, and deliverables management.
- Design and creation of two short videos. One for promotion of the event and Cape Town, and one post event summary video.

- Design and creation of a promotional video for Cape Town and CRF to be used as time filler during the conference.

5.6 Finance Administration & Compliance

- **Delegate registration & payment processing**, banking fee management, reconciliation, and reporting.
- Establish a **separate, audited account** for delegate fees; ensure compliance with PFMA/Treasury rules and financial controls.
- Transfer of any profits to the CIPC or any other organisation CIPC may indicate.
- Manage **insurance** and **contingency** provisioning per budget.

5.7 Stakeholder & Governance Support

- Secretariat functions for the CRF Steering Committee (meeting scheduling, minutes, action tracking).
- Risk, issues, and change request log administration; formal **change control** to accommodate CRF/CIPC adjustments.

5.8 Staffing, Contracting, Approvals, Safety and Security Protocol

- End-to-end **event team** staffing (competent events safety officer, coordination, accreditations, registration, ushers & VIP protocol) safety and **security** planning. Compilation of the necessary event safety and security plans and/or files are subject to acceptance by the CIPC and the venue. A supplementary list of the required event safety and security file content will be provided to the awarded bidder (Compliance to the event file content provisions is compulsory).
- Photographer/videography team management.
- Facilitate the necessary processes, documentation and submission to the City of Cape Town Events Permit's Office. Ensure the subsequent provision of the Event Compliance Certificate prior to the event date.
- Where temporary structures are applicable, an approved building control file prepared by a structural engineer. Includes the approval of floor plans.
- Each sourced entity shall have their own public liability insurance cover of not less than ten million rand.
- Ensure adequate security and disaster management measures are in place and this must be done in consultation with CIPC Facilities and Security.

5.9 Travel & Accommodation Logistics (Selected Groups)

- Coordinate travel and accommodation for **CIPC delegation**, speakers/panellists, and VIPs (where required), including shuttles and car rental.

- Sourcing additional accommodation for delegates within a 5 km radius of the primary conference centre. Transport to and from the conference centre to the various alternative accommodation sites, excursions, from airport to accommodation sites and from the accommodation sites back to the airport.
- The conference centre must have accommodation available at the conference venue itself.
- Transport must be luxury coaches with aircon, and drop-down screens for longer journeys, in-bus microphone, and tour guide to educate and entertain delegates during transportation.

5.10 Post Event Deliverables

- Final report (attendance, finances, KPIs), post-implementation review, content repository, and media assets hand-over to CIPC.
- Distribution of materials to delegates
- Post conference survey.

6. Key Parameters & Assumptions

- **Delegates:** 250; **speakers/panelists ~30.**
- **Duration:** Proposed **5 days**
 - Day 1: preparatory and CRF AGM + cocktail;

9. DEFINITIONS

9.1 The Companies and Intellectual Property Commission [hereinafter referred to as “CIPC”] was in terms of the provisions of the Public Finance Management Act (PFMA), established as a trading entity on 4 March 2002. Its formulation brought together the South African Companies Registration Office (SACRO) and the South African Patents and Trademarks Office (SAPTO), both former directorates of **the dti**.

9.2 **CIPC**, a trading entity within the Department of Trade and Industry, exists to register businesses and intellectual property rights, maintain related registers and develop information for disclosure to stakeholders.

9.3 **“Acceptable Bid”**-means any bid, which, in all respects complies with the specifications and conditions of the Request for bid as set out in this document.

9.4 **“Acts”** – Means the Preferential Procurement Policy Framework Act. (Act No 5 of 2000).

9.5 **“Agent”** ” – means a person mandated by another person (“the principal”) to do business for and on behalf of or to represent in business transaction the principal, and thereby acquire rights for the principal against an organ of state and

incur obligations binding the principal in favour of an organ of state.

- 9.6 **“Bid”** - means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services or goods.

- 9.23 **“Rand Value”** - means the total estimated value of a contract in Rand denomination, which is calculated at the time of proposal invitations and includes all applicable taxes and excise duties.
- 9.24 **“Successful Vendor”** - means the organization or person with whom the order is placed or who is contracted to execute the work as detailed in the bid.
- 9.25 **“Prime Vendor”** – means any person (natural or juristic) who forwards an acceptable proposal in response to this RFB with the intention of being the main contractor should the proposal be awarded to him/her.

11. GENERAL RULES AND INSTRUCTIONS.

11.1 CONFIDENTIALITY.

11.1.1 The information contained in this document is of a confidential nature, and must only be used for purposes of responding to this RFB. This confidentiality clause extends to Bidder partners and/or implementation agents, whom the Bidder may decide to involve in preparing a response to this RFB.

11.1.2 For purposes of this process, the term “Confidential Information” shall include all technical and business information, including, without limiting the generality of the foregoing, all secret knowledge and information (including any and all financial, commercial, market, technical, functional and scientific information, and information relating to a party’s strategic objectives and planning and its past, present and future research and development), technical, functional and scientific requirements and specifications, data concerning business relationships, demonstrations, processes, machinery, know-how, architectural information, information contained in a party’s software and associated material and documentation, plans, designs and drawings and all material of whatever description, whether subject to or protected by copyright, patent or trademark, registered or un-registered, or otherwise disclosed or communicated before or after the date of this process.

11.1.3 The receiving party shall not, during the period of validity of this process, or at any time thereafter, use or disclose, directly or indirectly, the confidential information of CIPC (even if received before the date of this process) to any person whether in the employment of the receiving party or not, who does not take part in the performance of this process.

11.1.4 The receiving party shall take all such steps as may be reasonably necessary to prevent CIPC’s confidential information coming into the possession of unauthorised third parties. In protecting the receiving party’s confidential information, CIPC shall use the same degree of care, which does not amount to less than a reasonable degree of care, to prevent the unauthorised use or disclosure of the confidential information as the receiving party uses to protect its own confidential information.

9. DEFINITIONS

- 9.1 The Companies and Intellectual Property Commission [hereinafter referred to as “CIPC”] was in terms of the provisions of the Public Finance Management Act (PFMA), established as a trading entity on 4 March 2002. Its formulation brought together the South African Companies Registration Office (SACRO) and the South African Patents and Trademarks Office (SAPTO), both former directorates of **the dti**.
- 9.2 **CIPC**, a trading entity within the Department of Trade and Industry, exists to register businesses and intellectual property rights, maintain related registers and develop information for disclosure to stakeholders.
